Pacific Raceways Expansion includes upgrades to the racing surfaces, bringing them current with national safety standards enabling the attraction of professional televised racing series.

Pacific Innovation Center will attract state research facilities and global leaders in innovation technology accelerating positive climate change with a focus in renewable energy driven vehicles.

Pacific Motorsports Park will bridge the gap between traditional fossil fuels and sustainable energy solutions.

Explanation of Classification: Pacific Innovation Center, at Pacific Raceways, consists of a Private Industrial Development that enables public/private partnerships centering around the acceleration of innovation technology in the automotive industry. Commercialization of this innovation technology will be a primary focus of the tech-campus.

Explanation of the Need to Expedite Project Permitting: Pacific Innovation Center seeks to become the first industry cluster of it's kind in the world. Timely environmental review and permitting will ensure Washington State's competitive advantage in attracting industry leaders.

Legislation No. 2011-0227, passed by the King County Council in March of 2012 established Pacific Raceways as a Demonstration Project and provides for exhaustive environmental review. Pacific Raceways is committed to the obligation to pay the costs associated with an expedited process and a full EIS.

Anticipated Date of Completion of Construction: The Pacific Raceways 2013 Master Plan contemplates phased construction beginning in 2016 and ending in 2026.

Anticipated Date of Commencement of Operations: Immediately following completion of environmental review and permitting. Currently estimated to be early 2016.
